Requirements for the end-of-semester signature

(Eg.: mid-term assessment of 40%)

If the number of class absences does not exceed 30% of the contact hours. **It follows that any freshman student must attend the course in person no later than the fourth week of the course. If this is not done for any reason, the course cannot be completed and no further discussion will take place.** To avoid any misunderstanding, we must declare that having a medical certificate does not exempt freshman students from attending classes. **In case the student repeats the course (for the second or third time), I exempt him/her from the course attendance if the student has previously obtained the end-of-semester signature.** Of course, attendance is still an advantage in such cases.

Re-takes for the end-of-semester signature (PTE TVSz 50§(2))

Type of examination (written, oral):

Accumulated knowledge is tested on the one hand, during the semester as a written exam: the students have to solve physical problems. These problems will be computational tasks. On the other hand, project work can be given and their solutions are also acceptable. It is very important to emphasize that **the results of the project's work should be reported orally**. This means that **the students must be able to answer the questions connected to the project work** asked by the lecturer. **Failing this, the project work will not be accepted even if the solution is correct**. Submitting a project work is not compulsory, but if successfully completed is equivalent to the final exam. In case the exam fails or the student wants to improve the result a retake exam will be organized (up to two times). **The first retake exam will be scheduled for week 13. The last one will be held in the first week of the examination period**. If someone's performance (during the semester) is better than 40% the student may receive a final grade (or improve it during the examination period).

The exam is successful if the result is minimum 40 %.

Calculation of the grade (TVSz 47§ (3))

The mid-term performance (sample tests) accounts for **0** %, the performance at the exam accounts for **100** % in the calculation of the final grade. Successfully completed project work is equivalent to the final exam.
